

Legendary Entertainment "Godzilla YouTube" Sweepstakes
Official Rules
January 28, 2014 – January 29, 2014

PRELIMINARY INFORMATION: NO PURCHASE NECESSARY. A purchase will not improve your chances of winning. Void where prohibited. The Legendary Entertainment "Godzilla YouTube" Sweepstakes ("**Sweepstakes**") will begin on January 28, 2014 at 3:00 PM PT and end on January 29, 2014 at 11:59 PM PT ("**Sweepstakes Period**"). All times in the Sweepstakes refer to Pacific Time ("**PT**"). Odds of winning depend upon the number of eligible entries received. Sweepstakes is subject to all applicable federal, state and local laws.

ELIGIBILITY: The Legendary Entertainment "Godzilla YouTube" Sweepstakes ("**Sweepstakes**") is open only to legal residents who are physically located in one (1) of the fifty (50) United States or the District of Columbia (void in Puerto Rico, all U.S. territories and possessions and all overseas military installations) who are at least 18 years of age or older at the time of entry. Officers, directors, and employees of Sweepstakes Entities (as defined below), members of these persons' immediate families (spouses and/or parents, children, and siblings, and their spouses, regardless of where they reside), and/or persons living in the same households as these persons (whether or not related thereto) are not eligible to enter or win the Sweepstakes. WINNER SELECTION AND NOTIFICATION: On or about January 29, 2013, five (5) potential Prize winners ("**Prize Winners**") will be selected in a random drawing by representatives of Sponsors from all eligible Entries received during the Sweepstakes Period (collectively, "**Winner**"). The JAMS Rules for selection of an arbitrator shall be followed, except that the arbitrator shall be experienced and licensed to practice law in California. All proceedings brought pursuant to this paragraph will be conducted in the County of Los Angeles. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.
