

**“The Great Wall Premiere Giveaway” Sweepstakes**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING.**

**PROMOTION DESCRIPTION:** “The Great Wall Premiere Giveaway” Sweepstakes (the **“Sweepstakes”**) begins on or about February 8, 2017 at 3:00 p.m. Eastern Time (**“ET”**) and ends on February 13, 2017 at 11:59 p.m. ET (the **“Promotion Period”**). At the end of the Promotion Period, a random drawing will be conducted from among all eligible entries received during the Promotion Period to select one (1) Grand Prize winner as more fully set forth below. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Legendary Pictures Productions LLC, 2900 W. Alameda Ave., Ste 1500, Burbank, CA 91505 (**“Sponsor”**), which shall be final and binding in all respects.

**ELIGIBILITY:** Only legal U.S. residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry are eligible to enter. Sponsor shall determine the correct answer to the trivia question for purposes of the Sweepstakes in its sole discretion. **Limit one (1) entry per person.** All entries must be received by the end of the Promotion Period. Any communication or information transmitted to Sponsor and/or the Website by electronic mail or otherwise is and will be treated as non-confidential and nonproprietary. **WINNER SELECTION AND NOTIFICATION:** After the Promotion Period, one (1) Grand Prize winner will be selected in a random drawing conducted by Sponsor from all eligible entries received throughout the Promotion Period. Each potential prize winner will be notified by direct message on their Facebook account. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential prize winner does not respond within two (2) days of the first notification attempt, or if a prize or prize notification is returned as unclaimed or undeliverable to such potential prize winner, such potential prize winner will forfeit the applicable prize and an alternate prize winner may be selected. connection with the arbitration as the arbitrator deems necessary to prevent the arbitration from being cost-prohibitive; and (9) with the exception of subpart (6) above, if any part of this arbitration provision is deemed to be invalid, unenforceable or illegal, or otherwise conflicts with the rules of JAMS, then the balance of this arbitration provision shall remain in effect and shall be construed in accordance with its terms as if the invalid, unenforceable, illegal or conflicting provision were not contained herein. If, however, subpart (6) is found to be invalid, unenforceable or illegal, then the entirety of this Arbitration Provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute.
