

**Legendary's "Ultimate SDCC Prize Pack" Sweepstakes  
OFFICIAL RULES**

**PROMOTION DESCRIPTION:** The Legendary's "Ultimate SDCC Prize Pack" Sweepstakes (the "Sweepstakes") begins on or about July 14, 2015 at 3:01 p.m. Eastern Time ("ET") and ends on July 20, 2015 at 11:59 p.m. ET (the "Promotion Period"). At the end of the Promotion Period, a random drawing will be conducted to select one (1) Grand Prize winner and ten (10) First Prize winners from among all eligible entries received during the Promotion Period as more fully set forth below. Entry in the Sweepstakes does not constitute entry into any other promotion, contest or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Legendary Pictures Productions, LLC, 2900 W. Alameda Ave., Ste 1500, Burbank, CA 91505 ("Sponsor"), which shall be final and binding in all respects.

**ELIGIBILITY:** The Sweepstakes is open only to entrants who are eighteen (18) or older at the time of entry, and is void in and to residents of countries currently subject to United States embargo or on the United States list of state sponsors of terrorism and where prohibited by law. Limit one (1) General Entry per person.

one (1) entry by subscribing to Legendary's YouTube channel and verifying you are subscribed to Legendary's YouTube channel through the Website (each, a "Legendary YouTube Subscribe Entry"); (v) one (1) entry by following Legendary on Instagram and verifying you are following Legendary on Instagram through the Website (each, an "Instagram Entry"); and (vi) one (1) entry by visiting the official Legendary website and verifying you visited the website through the Website (each, a "Website Visit"). Limit one (1) Twitter Entry, one (1) Sharing Entry, one (1) Legendary YouTube Subscribe Entry, one (1) Legendary Tumbler Entry, one (1) Legendary Website visit, and one (1) Instagram Entry per person.

In addition, you will be provided the opportunity to share a link to the Sweepstakes (the "Sweepstakes Link") with your friends through your email account. In the event one of your friends uses the Sweepstakes Link to enter the Sweepstakes during the Promotion Period, you will receive three (3) additional entries into the Sweepstakes (each, a "Refer a Friend Entry"). Please follow etiquette and forward the Sweepstakes Link only to people you know.

All entries must be received by the end of the Promotion Period in order to participate. The Website's database clock will be the official time keeper for this Sweepstakes. All requested information must be included in the registration form provided on the Website to be eligible to win. Proof of registration is not considered proof of delivery to or receipt by Sponsor of such entry. Entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other website or e-mail, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. **WINNER SELECTION AND NOTIFICATION:** After the Promotion Period, one (1) Grand Prize winner and ten (10) First Prize winners will be selected from all eligible entries received during the Promotion Period. Sponsor will contact each prize winner using the information provided at the time of entry. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within ten (10) days of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to such potential winner, such potential winner will forfeit his or her prize

and an alternate winner may be selected. The approximate retail value ("ARV") of the Grand Prize is \$411.73.

First Prize. Ten (10) First Prizes are available. The First Prize consists of (i) one (1) Google Cardboard headset. The approximate retail value ("ARV") of the First Prize is \$24.99.

**GOVERNING LAW/JURISDICTION:** ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR SPONSOR IN CONNECTION WITH THE SWEEPSTAKES SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE INTERNAL LAWS OF THE STATE OF CALIFORNIA WITHOUT GIVING EFFECT TO ANY CHOICE OF LAW OF CONFLICT OF LAW RULES OR PROVISIONS THAT WOULD CAUSE THE APPLICATION OF ANY OTHER STATE'S LAWS.

If, however, subpart (vi) is found to be invalid, unenforceable or illegal, then the entirety of this arbitration provision shall be null and void, and neither entrant nor Sponsor shall be entitled to arbitrate their dispute.
